Any SCC student who has earned an Associate of Arts in Teaching and adheres to the transfer guidelines is guaranteed that MSU will accept designated freshman and sophomore education credits and all general education credits and will apply such to the Bachelor's degree in a manner consistent with the transfer guidelines.

Criteria for acceptance into one of the above-referenced programs leading to the Bachelor's degree at MSU will be the same for transfer as for native students.

SCC, upon request of students, will provide verification of completed courses to MSU through its Office of the Registrar. The transcript of students transferring from SCC will be evaluated by the Office of Admissions at MSU.

Transfer students from SCC will have access to financial aid, scholarships, and student services on the same basis as native students.

Section II: Transfer of Credit

Transfer students from SCC who have completed an Associate of Arts in Teaching degree, upon acceptance into one of the above-referenced programs leading to the Bachelor's degree at MSU will have junior standing at MSU.
