Articulation Agreement between

St. Charles Community College and Southeast Missouri State University

A.A. Business Administration to BSBA in Business Administration

This document specifies the terms for a transfer agreement between Southeast Missouri State University (hereinafter referred to as "Southeast") and St. Charles Community College (hereinafter referred to as "SCC") and is intended to benefit students at both institutions. This articulation agreement will lead to the awarding of college credit by Southeast for courses successfully completed by students at SCC.

This articulation agreement is intended to prepare SCC students completing the Associate of Arts degree in Business Administration for Southeast Bachelor of Science in Business Administration with major in Business Administration. Southeast's Business Administration degree is available on its campus or through online delivery.

SCC and Southeast agree that, in accordance with the CBHE Credit Transfer Guidelines 2005, "AA, AS, and AAS transfer students may choose to complete additional lower-division requirements at two-year institutions to meet the lower-division prerequisites and/or lower-division graduation requirements established by the baccalaureate institution.

To clarify, students may transfer more than 64 credit hours for lower division courses from either Missouri associate degree-granting or baccalaureate degree-granting institutions. Any additional lower division course credits above 64 credit hours will be accepted in transfer if the credits are applicable to the baccalaureate degree or are prerequisites for an upper division course in the major."

To insure the SCC student is ready to enroll in the Southeast junior level business courses, the student must follow the recommended plan of study attached.

This agreement will become effective with the 2015-16 academic year.
