UNDERGRADUATE ASSOCIATE DEGREE TRANSFER AGREEMENT BETWEEN STEPHENS AND ST. CHARLES COMMUNITY COLLEGE

Article I: Agreement on Principle

OBJECTIVE: This agreement is made with the intent to facilitate the transfer of students from the St. Charles College to Stephens College. By this agreement, St. Charles Community College and Stephens College express a shared commitment to increased opportunities for student access to and success in higher education. By clarifying transfer policies and procedures that assure articulation between programs, the institutions seek to assist students in making a seamless transfer from the Associate to the baccalaureate degree.

Article II: Terms of Agreement

It is agreed that those individuals who receive a St. Charles Community College's Associate of Arts Degree and meet all of the criteria listed within the General Education Distributive Model (Appendix A) will be accepted without further review of academic credentials at Stephens College. *CRITERIA*: The following criteria shall be met by students seeking to participate in this agreement are as follows:

- a) The student will have received the Associate of Arts from St. Charles Community College on or after the effective date of this Agreement.
- b) The student's cumulative grade point average at St. Charles Community College must be 2.5 or higher.
- c) A grade of "C," or better, is required in <u>all</u> courses to be applied toward the bachelor's degree.

 Both St. Charles Community College And Stephens College Agree To The Following Responsibilities:
 - a) Both parties must inform potential students about the agreement. Examples of possible informational activities may include, but are not limited to, media announcements, brochures or fliers, information sessions for potential transfer students at St. Charles Community College.
 - b) Faculty and staff at both institutions will share the information in this agreement with interested and qualified students.
 - c) Faculty from each college will confer to develop an advising plan for each student based on student's intended major.

Stephens College Agrees To The Following Terms:

a) Acceptance of all courses as outlined in the General Education Distributive Model (Appendix A) with a grade of "C" or better as part of the St. Charles Community College Associate of Arts Degree;



- b) Waiver for undergraduate application fee;
- Early advising and degree planning for students admitted under this agreement. This includes a
 review of transcript credit and the development of an academic plan by faculty within the student's
 chosen area of study;
- d) Eligibility for Transfer Students Scholarships:
 - a. Phi Theta Kappa Founders Scholarship Recipient must be a member of Phi Theta Kappa for a full semester and have at least a 3.5 GPA \$15,000 per year Renewable based on minimum 3.0 GPA
 - b. Transfer Presidential Scholarships Recipient must have earned at least 12 hours of transfer credit with a 3.5-4.0 GPA \$10,000-\$15,000 per year Renewable based on minimum 3.0 GPA
 - c. Transfer Scholarship Recipient must have earned at least 12 hours of transfer credit with a 2.5-3.4 GPA \$5,000-\$8,000 per year Renewable based on minimum 2.5 GPA

Article III - Maintenance and Review Procedures

Stephens College and St. Charles Community College agree to identify at least one individual at each institution to annually evaluate the continuing effectiveness of this agreement, to facilitate changes to and development of the program, and to advise students in exceptional situations. This agreement is made and entered into in the academic year of 2015 and remains in force unless changed in writing by mutual agreement of both parties. This agreement may be amended at any time with the approval of both parties and is subject to annual review. This agreement is effective as of ____1, 2015 until ____1, 2018 and will be reviewed annually by the Chief Academic Officers and appropriate faculty at each institution. If not renewed, St. Charles Community College students who matriculate under this agreement before its termination will have three additional years to be admitted under the terms of this agreement.
